

Be It Resolved That the following bylaw amendments be adopted:

AMENDMENT 1:

Section 8: Board of Directors Membership and Responsibilities

b. Proportionate representation will be based upon the number of full-time students in the Faculty or School. Faculties consisting of less than seven hundred and fifty (750) but not less than fifty (50) will be entitled to one (1) representative. Faculties consisting of less than one thousand and five hundred (1500) but not less than seven hundred and fifty (750) students shall be entitled to two (2) representatives. Faculties consisting of not less than one thousand and five hundred (1500) students shall be entitled to four (4) representatives.

Change to:

b. Representation will be based on the principle of one (1) representative position per Faculty/School, with the following exceptions:

- i. Humanities & Social Sciences: two (2) representatives**
- ii. Science: two (2) representatives**

In the event of a faculty/school representative or a constituency representative vacancy, the seat may be held by a non-voting member (called an observing member) until the next election, at which point the seat shall be advertised as open and nominations will be accepted from members of that ward. Observing members may be nominated by the respective group or collection of groups, where duly recognized by the Students' Union, listed below:
